- One (1) recent high-resolution professional photo per person (approx. 2" x 2"). Photos must be on the white background! Please do not staple!
- India application will be submitted on your behalf by GenVisa staff online, using the information provided on India E-Visa Request form enclosed in the visa kit.
- Prepaid self-addressed first-class mail envelope if you wish to receive a physical copy of your E-Visa.
- Payment: a check or money order payable to GenVisa in US Dollars, drawn on a US bank. Complete and return this entire form with the requested materials – use a traceable form of mail. Important: Do not send your request/materials more than 4 months prior to your tour departure date.

Processing generally takes up to 3 weeks. If you need your E-Visa within 14 days: add \$45 per person for expedited service. For processing within 7 business days: add \$75 per person. Regular processing time: 15 business days (3 weeks). Add \$45 to expedite within 10 business days. Add \$75 to expedite within 7 business days. **Eligibility:**

- 1. International Travelers whose sole objective of visiting India is recreation, sightseeing, casual visit to meet friends or relatives, short duration medical treatment or casual business visit.
 - a. Passport should have at least six months validity.
 - b. International Travelers should have return ticket or onward journey ticket, with sufficient money to spend during his/her stay in India.
 - c. International Travelers having Pakistani Passport or Pakistani origin have to apply for regular Visa at Indian Mission.
 - d. Not available to Diplomatic/Official Passport Holders.

Instructions for E-Visa:

- 1. Applicants of the eligible countries may apply on-line minimum 4 days in advance of the date of arrival with a window of 120 days. Example: If you are applying on 1st September then applicant can select arrival date from 5th of September to 4th of January.
- 2. E-Visa fee, once submitted, is nonrefundable.
- 3. Applicant should carry a copy of E-Visa along with him/her at the time of travel.
- 4. Biometric details of the applicant will be captured at Immigration on arrival in India.
- 5. The validity of tourist E-Visa is 365 days from the date of issue for a stay up to 180 days for citizens of USA, UK, Canada and Japan from the date of arrival in India.
- 6. E-Visa is valid for entry through 25 designated Airports (i.e. Ahmedabad, Amritsar, Bagdogra, Bengaluru, Calicut, Chennai, Chandigarh, Cochin, Coimbatore, Delhi, Gaya, Goa, Guwahati, Hyderabad, Jaipur, Kolkata, Lucknow, Mangalore, Mumbai, Nagpur, Pune, Tiruchirapalli, Trivandrum, Varanasi & & Vishakhapatnam) and designated seaports (Cochin, Goa, Mangalore, Chennai, Mumbai).
- 7. Tourist E-Visa, once issued on arrival, cannot be extended.

DOCUMENTS REQUIRED:

- 1. Clear legible <u>COLOR</u> copy of the First (Data) Page of Passport in actual size (professional copy only!) Please make sure that the passport is signed!
- 2. Professional *current* passport photograph meeting the following requirements:
 - a. Photo should present full face, front view, eyes open and without glasses.
 - b. The height and width of the Photo must be equal.
 - c. Background should be plain light colored or white.
 - d. No shadows on the face or on the background, no borders.
