

# TOURIST VISA REQUIREMENTS FOR INDIA E-TOURIST VISA

**Total cost - One person - \$104**

**Total cost - Two people - \$208**

Cost includes service fees, government fees\* and return delivery by email.

## Please Send to GENERATIONS VISA SERVICE: (see address below)

- **High Resolution color copy of the data page of your passport**, with at least **six months of remaining** validity beyond the travel date. The passport should have at least two blank pages for stamping by the Immigration Officer. If you need help securing, renewing, or updating your passport, please contact GenVisa at (800) 845-8968 for requirements and fees.
- **One (1) recent high-resolution professional photo** per person (approx. 2" x 2"). **Photos must be on the white background! Please do not staple!**
- India application will be submitted on your behalf by GenVisa staff online, using the information provided on **India E-Visa Request form** enclosed in the visa kit.
- Prepaid self-addressed first-class mail envelope if you wish to receive a physical copy of your E-Visa.
- **Payment:** a check or money order payable to GenVisa in US Dollars, drawn on a US bank.  
Complete and *return this entire form* with the requested materials – use a traceable form of mail.  
**Important: Do not send your request/materials more than 4 months prior to your tour departure date.**

Processing generally takes up to 3 weeks. If you need your E-Visa **within 14 days: add \$45 per person for expedited service.** For processing **within 7 business days: add \$75 per person.** If you are a non-US citizen, call for entry requirements. ## **India Tourist E-Visa Service: \$104 per application**

*E-Visa is available for holders of passport of following countries:* Australia, Brazil, Cambodia, Cook Islands, Djibouti, Fiji, Finland, Germany, Indonesia, Israel, Japan, Jordan, Kenya, Kiribati, Laos, Luxembourg, Marshall Islands, Mauritius, Mexico, Micronesia, Myanmar, Nauru, New Zealand, Niue Island, Norway, Oman, Palau, Palestine, Papua New Guinea, Philippines, Republic of Korea, Russia, Samoa, Singapore, Solomon Islands, Thailand, Tonga, Tuvalu, UAE, Ukraine, USA, Vanuatu, Vietnam.

*Regular processing time: 15 business days (3 weeks). Add \$45 to expedite within 10 business days. Add \$75 to expedite within 7 business days.*

### *Eligibility:*

1. International Travelers whose sole objective of visiting India is recreation, sightseeing, casual visit to meet friends or relatives, short duration medical treatment or casual business visit.
  - a. Passport should have at least six months validity.
  - b. International Travelers should have return ticket or onward journey ticket, with sufficient money to spend during his/her stay in India.
  - c. International Travelers having Pakistani Passport or Pakistani origin have to apply for regular Visa at Indian Mission.
  - d. Not available to Diplomatic/Official Passport Holders.

### *Instructions for E-Visa:*

1. Applicants of the eligible countries may apply on-line minimum 4 days in advance of the date of arrival with a window of 120 days. Example: If you are applying on 1st September then applicant can select arrival date from 5<sup>th</sup> of September to 4th of January.
2. E-Visa fee, once submitted, is nonrefundable.
3. Applicant should carry a copy of E-Visa along with him/her at the time of travel.
4. Biometric details of the applicant will be captured at Immigration on arrival in India.
5. **The validity of tourist E-Visa is 365 days from the date of issue for a stay up to 180 days for citizens of USA, UK, Canada and Japan from the date of arrival in India.**
6. E-Visa is valid for entry through 25 designated Airports (i.e. Ahmedabad, Amritsar, Bagdogra, Bengaluru, Calicut, Chennai, Chandigarh, Cochin, Coimbatore, Delhi, Gaya, Goa, Guwahati, Hyderabad, Jaipur, Kolkata, Lucknow, Mangalore, Mumbai, Nagpur, Pune, Tiruchirapalli, Trivandrum, Varanasi & Vishakhapatnam) and designated seaports (Cochin, Goa, Mangalore, Chennai, Mumbai).
7. Tourist E-Visa, once issued on arrival, cannot be extended.

**DOCUMENTS REQUIRED:**

1. Clear legible **COLOR** copy of the First (Data) Page of Passport in actual size (professional copy only!) Please make sure that the passport is signed!
2. Professional **current** passport photograph meeting the following requirements:
  - a. Photo should present full face, front view, eyes open and without glasses.
  - b. The height and width of the Photo must be equal.
  - c. Background should be plain light colored or white.
  - d. No shadows on the face or on the background, no borders.

Please answer **legibly** and completely ALL the questions below in block letters and return to GenVisa with the rest of the required information listed on the Tourist Visa Requirements form.

***Please Note: The online visa application form is an Indian government run website; therefore GenVisa is unable to offer technical support to applicants completing their own applications. Applicants, who chose to complete online application themselves, should take great care to fill in the information correctly. Any mistakes will delay processing and/or require the process to be repeated.***
