

TOURIST VISA REQUIREMENTS **FOR KENYA (single entry) AND TANZANIA E-VISAS**

Total cost One person - \$272

- ___ A **color copy of the data pages** of your passport (pp 2-3) along with a **copy of the front cover** (blue cover with the word PASSPORT). Your passport must have six months of remaining validity beyond the travel date, and two empty visa pages. For help securing or renewing your passport, call GenVisa at 800-845-8968.
- ___ **Two (2)** recent high-resolution professional **photos** per person (approx. 2" x 2"). **Photos must be on the white background! Please do not staple!**
- ___ Completed and signed **visa applications** per person for each country. Kenya and Tanzania applications will be submitted on your behalf, using the information provided on **E-Visa Application forms**.
- ___ **Tanzania Declaration Statement**, one per traveler, signed and dated (enclosed in the visa kit).
- ___ **Tanzania E-Visa Disclaimer**, one per traveler, signed and dated (enclosed in the visa kit).
- ___ Copy of **concise (1-3 pages long), itemized travel itinerary** from your tour operator, showing both flights and hotel accommodation information **IN EACH TRAVELER'S NAME**, no exception. **Do not send brochure-type, day-by-day itinerary, as it will be rejected by the Embassy!**
- ___ Prepaid **self-addressed first-class envelope** if you wish to receive physical copies of your receipts.
- ___ **Payment:** a check or money order payable to GenVisa in US Dollars, drawn on a US bank.

Complete and return this entire form with the requested materials.

Important: Do not send your visa materials more than 90 days prior to your trip date.

Tanzania E-visa is valid for multiple entries within 1 year from the date of issue with stays up to 90 days.

Kenya E-visa is valid for a single entry within 90 days of the date of issue.

Processing takes up to 4 weeks. If you need your E-visas **within 21 days:** add \$75 per person for expedited service, **within 14 days:** add \$110 per person for Express service. These requirements are for the U.S. passport holders only.  - c. No shadows on the face or on the background.
3. GenVisa Order Form (enclosed) with pertinent contact and payment information.

TANZANIA E-VISA DISCLAIMER

The United Republic of Tanzania E-Visa Application System performs checks against law enforcement databases. All foreigners who are desirous of entering the United Republic of Tanzania shall obtain a Visa using the online application system before being granted boarding.

If your visa or permit application is approved, it establishes that you are eligible for the approved visa or permit but does not establish that your application is approved.

Upon arrival to the United Republic of Tanzania (at the selected point of entry) or the Immigration Office Headquarters, you will be inspected by an Immigration Officer who may determine if your application is finally approved. All information provided by you, or on your behalf by a designed third party, must be true and correct.

A visa application approval may be revoked at any time and for any reason, such as new information influencing eligibility. You may be subject to administrative or criminal penalties if you knowingly and willfully make a materially false, fictitious, or fraudulent statement or representation in an electronic visa application submitted by you or on your behalf.

Instructions for E-Visa:

1. Applicants of the eligible countries may apply online minimum 15 days in advance of the date of arrival with a window of 90 days.
2. E-Visa fee, once submitted, is nonrefundable.
3. The applicant should carry a copy of E-Visa along with him/her at the time of travel.
4. The validity of **tourist E-Visa is 12 months from the date of issue for a stay up to 90 days for citizens of the USA** from the date of arrival in Tanzania.
5. E-Visa is valid for entry through 3 designated Airports Julius Nyerere International Airport (JNIA); Kilimanjaro International Airport (KIA) and Abeid Amani Karume International Airport (AAKIA); and two bus/car/rail borders: Namanga border and Tunduma border.
6. Tourist E-Visa, once issued on arrival, cannot be extended.
7. The Tanzania Immigration Services Department may give or withhold reasons for rejection of Visa to the applicant;

There are some countries which their nationals require special clearance from the Commissioner General of Immigration or the Commissioner of Immigration (Zanzibar) before issuance of the Visa. These countries fall under the **Referral Visa Category**.

Applicants whose nationals fall under the **Referral Visa category** are **not advised** to book flight tickets or make payments for any reservations in Tanzania before they get approval for their Visa. Applicants of Referral Visa are advised to apply at least three months before their date of travel; What is recommended for the passport holders of those countries is for applicants to seek permission clearance first, through their host in Tanzania. In this case, the host submits the request letter detailing the reasons and duration of stay of the visitor, to the Commissioner-General of immigration, or the Commissioner of Zanzibar, if the applicant wishes to visit Zanzibar.
