### **TANZANIA E-VISA DISCLAIMER**

The United Republic of Tanzania E-Visa Application System performs checks against law enforcement databases. All foreigners who are desirous of entering the United Republic of Tanzania shall obtain a Visa using the online application system before being granted boarding.

If your visa or permit application is approved, it establishes that you are eligible for the approved visa or permit but does not establish that your application is approved.

Upon arrival to the United Republic of Tanzania (at the selected point of entry) or the Immigration Office Headquarters, you will be inspected by an Immigration Officer who may determine if your application is finally approved. All information provided by you, or on your behalf by a designed third party, must be true and correct.

A visa application approval may be revoked at any time and for any reason, such as new information influencing eligibility. You may be subject to administrative or criminal penalties if you knowingly and willfully make a materially false, fictitious, or fraudulent statement or representation in an electronic visa application submitted by you or on your behalf.

#### Instructions for E-Visa:

- 1. Applicants of the eligible countries may apply online minimum 15 days in advance of the date of arrival with a window of 90 days.
- 2. E-Visa fee, once submitted, is nonrefundable.
- 3. The applicant should carry a copy of E-Visa along with him/her at the time of travel.
- 4. The validity of tourist E-Visa is 12 months from the date of issue for a stay up to 90 days for citizens of the USA from the date of arrival in Tanzania.
- 5. E-Visa is valid for entry through 3 designated Airports Julius Nyerere International Airport (JNIA); Kilimanjaro International Airport (KIA) and Abeid Amani Karume International Airport (AAKIA); and two bus/car/rail borders: Namanga border and Tunduma border.
- 6. Tourist E-Visa, once issued on arrival, cannot be extended.
- 7. The Tanzania Immigration Services Department may give or withhold reasons for rejection of Visa to the applicant;

There are some countries which their nationals require special clearance from the Commissioner General of Immigration or the Commissioner of Immigration (Zanzibar) before issuance of the Visa. These countries fall under the **Referral Visa Category.** 

Applicants whose nationals fall under the **Referral Visa category** are **not advised** to book flight tickets or make payments for any reservations in Tanzania before they get approval for their Visa. Applicants of Referral Visa are advised to apply at least three months before their date of travel; What is recommended for the passport holders of those countries is for applicants to seek permission clearance first, through their host in Tanzania. In this case, the host submits the request letter detailing the reasons and duration of stay of the visitor, to the Commissioner-General of immigration, or the Commissioner of Zanzibar, if the applicant wishes to visit Zanzibar.
