Nepal visa is valid for multiple entries for a stay up to 15 days from date of entry.

Processing takes up to 3 weeks. If you need your passport **within 14 days**: add \$55 per person for expedited service. If you are departing **within 7 days**: call GenVisa prior to sending the materials. 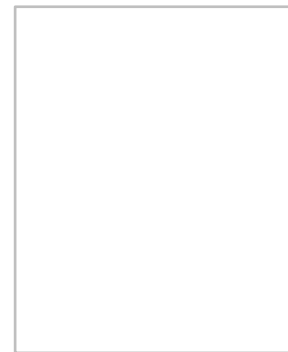
