- \_\_\_ Prepaid self-addressed first-class mail envelope if you wish to receive a physical copy of your E-Visa.
- \_\_\_ Payment: a check or money order payable to GenVisa in US Dollars, drawn on a US bank.

**Important:** Do not send your passport and visa materials more than 35 days prior to your trip date.  
Oman E-visa is valid for a single entry of up to 30 days stay and is issued electronically.  
No visa stamps or labels are put in your passport.

Processing takes 7-10 days. If you need your E-Visa **within 5 business days**: add \$35 per person for expedited service.
