A clear High Resolution COLOR copy of the data page of your passport in actual size (photos are not acceptable), with at least six months remaining validity beyond the travel date. **YOUR ACTUAL PASSPORT MUST BE SIGNED!** If you need help securing, renewing, or updating your passport, please contact GenVisa at (800) 845-8968 for requirements and fees.

Two (2) High Resolution Passport Photo taken within 6 months on white background without any shadows – 2"x 2", front view, no smiling, and no glasses. No homemade photos, please!

A copy of the Bank statement. Printed bank statement showing *transactions for the last 30 days and balance of at least US\$ 2,000.00 for travel*. Please refer to the *Brazil E-Visa Check list for specific details*

Itemized tour and flight itinerary, showing dates of travel, arrival and departure points in each traveler's name. Please refer to the *Brazil E-Visa Check list for specific details*.

Brazil ETA Request Form and Declaration form per person (attached).

Payment: a check or money order payable to GenVisa in US Dollars and drawn on a US bank.

Complete and return this form with the requested materials to GenVisa to the address below.

Important: Do not send your materials more than 3 months prior to your trip date. An E-Visa is an official authorization for a visit to Brazil for tourism purposes. E-Visa is valid for 2 years or until passport expiration date from the date of issue for multiple entries of up to 90 days per visit. The E-Visa is submitted online with the E-Visa approval communicated via email. You MUST always carry the E-Visa approval with you.

Processing takes up to 6 weeks. If you need your E-Visa **within 30 days** of submission (subject to approval): add \$75 per person for expedited service. If you are **traveling within 3 weeks, please contact GenVisa prior to sending your materials.** These requirements are for nationals of United States, Canada, and Australia.

Brazil E-Visa Checklist

The following documents are required by the Brazilian government for successful E-Visa processing. Failure to provide those materials in a specified manner will result in delays, additional processing fees (\$45 application resubmission fee for all suspended applications), and rejections of your E-Visa. By signing this checklist below, you agree to these terms.



A clear High Resolution COLOR scan of the data page of your passport (pp. 2-3) in actual size, positioned in the middle of a page (snapshots taken on a cell phone are not acceptable). YOUR ACTUAL PASSPORT MUST BE SIGNED!

Two Identical Passport Photos

Two professionally taken passport photos, 2" x 2", on completely white background. **No smile or teeth shown. Hair cannot cover forehead; ears must be shown!**



The following photos will be rejected:

1. Home photos taken at home on your cellphone.
 2. Xerox copies that are made on a copy machine.
 3. Photos used to procure your passport, even if your passport was recently renewed.

A copy of the most recent Bank Statement in each traveler's name.

Include a copy of your MOST RECENT bank statement. ***Please make sure ALL the following government requirements are met:***



1. Shows **no less than \$2000 in available balance per traveler**, \$4,000 for two people on a joint account.
 2. Shows **thirty days of transaction activity**,
 3. **Savings accounts, CD accounts, and retirement accounts showing no activity other than monthly service fees and accrued interest will not be accepted.**
 4. **The Statement date CANNOT be outside the 15-day window** – most of the activities shown in the statement must fall within 30 days.
 5. Modifications to the bank statement will not be accepted. You can request a redacted version of the statement from the bank with a partially obstructed account number.

- a. For Ocean Cruises - Itemized cruise itinerary in each traveler's name, showing dates of arrival and ports of call in Brazil. Must include separate Air itinerary if part of the cruise includes arrival and/or departure by plane,
- b. For Land Tours – Itemized airline itinerary with arrival and departure flight information. No exceptions

Amendments and Endorsements pages in the back of the passport are not suitable for visa placement. The Brazil E-Visa is electronic and will not be stamped inside the passport. The E-Visa is submitted online with the E-Visa approval communicated via email. You MUST always carry the E-Visa approval with you.

DECLARATION FORM

I am aware of and consent to the following: any personal data concerning me that appears on this visa application form will be supplied to the relevant authorities in Brazil and processed by those authorities, if necessary, for a decision on my visa application.

I am aware that any false statements will lead to my application being rejected or to the annulment of a visa already granted and may also render me liable to prosecution under the law of the Brazilian State that deals with applications.

I undertake to leave the territory of Brazil upon expiration of the visa if granted.

I have been informed that possession of a visa is only one of the prerequisites for entry into the territory of Brazil. The mere fact that a visa has been granted to me does not mean that I will be entitled to compensation if I fail to comply with relevant provisions of the laws of Brazil. The prerequisites for entry will be checked again on entry into the territory of Brazil.
