

TOURIST VISA REQUIREMENTS FOR INDIA E-Visa and NEPAL

Total cost - One person - \$261

Total cost - Two people - \$474

For the **Overnight Return Delivery** upgrade please add an additional \$15.00 per address.

For delivery outside the **contiguous** U.S. please add an additional \$90.00.

- ___ Your **signed passport**: having three completely blank "visa" pages & six months validity beyond the travel date. For help with passport processing call GenVisa at **800-845-8968**.
- ___ **Two (2)** recent professional, high resolution, passport **photos** per person (approx. 2" x 2") on white background without glasses. Please do not attach photos – GenVisa staff will do it for you!
- ___ **One** completed and signed **application** per person **per country**. India application will be submitted on your behalf by GenVisa staff, using the information provided on India **E-Visa Request form** enclosed in the kit.
- ___ A copy of your **flight/travel itinerary in each applicant's name** provided by the tour operator.
- ___ A clear photocopy of **Driver's License** as proof of residence for each person.
- ___ A clear photocopy of the **Alien Registration Card for Non-US citizens**, permanent residents in the US.
- ___ **Payment**: a check or money order payable to GenVisa in US Dollars and drawn on a US bank.

Complete and return this entire form with the requested materials.

Important: Do not send your passport/materials more than 4 months prior to your tour departure date.

Visa processing generally takes up to 5 weeks. If you need your passport returned **within 30 days** of submission: add \$70 per person for expedited service. If you are departing **within 15 days**: add \$90 per person for expedited service. India Tourist E-Visa

E-Visa is available for holders of passport of following countries: Australia, Brazil, Cambodia, Canada, Cook Islands, Djibouti, Fiji, Finland, Germany, Indonesia, Israel, Japan, Jordan, Kenya, Kiribati, Laos, Luxembourg, Marshall Islands, Mauritius, Mexico, Micronesia, Myanmar, Nauru, New Zealand, Niue Island, Norway, Oman, Palau, Palestine, Papua New Guinea, Philippines, Republic of Korea, Russia, Samoa, Singapore, Solomon Islands, Thailand, Tonga, Tuvalu, UAE, Ukraine, USA, Vanuatu, Vietnam.

Eligibility:

1. International Travelers whose sole objective of visiting India is recreation, sightseeing, casual visit to meet friends or relatives, short duration medical treatment or casual business visit.
 - a. Passport should have at least six months validity.
 - b. International Travelers should have return ticket or onward journey ticket, with sufficient money to spend during his/her stay in India.
 - c. International Travelers having Pakistani Passport or Pakistani origin have to apply for regular Visa at Indian Mission.
 - d. Not available to Diplomatic/Official Passport Holders.

Instructions for E-Visa:

1. Applicants of the eligible countries may apply on-line minimum 4 days in advance of the date of arrival with a window of 120 days. Example: If you are applying on 1st September then applicant can select arrival date from 5th of September to 4th of January.
2. E-Visa fee, once submitted, is nonrefundable.
3. Applicant should carry a copy of E-Visa along with him/her at the time of travel.
4. Biometric details of the applicant will be captured at Immigration on arrival in India.
5. **The validity of tourist E-Visa is 365 days from the date of issue for a stay up to 180 days for citizens of USA, UK, Canada and Japan from the date of arrival in India.**
6. E-Visa is valid for entry through 25 designated Airports (i.e. Ahmedabad, Amritsar, Bagdogra, Bengaluru, Calicut, Chennai, Chandigarh, Cochin, Coimbatore, Delhi, Gaya, Goa, Guwahati, Hyderabad, Jaipur, Kolkata, Lucknow, Mangalore, Mumbai, Nagpur, Pune, Tiruchirapalli, Trivandrum, Varanasi & Vishakhapatnam) and designated seaports (Cochin, Goa, Mangalore, Chennai, Mumbai).
7. Tourist E-Visa, once issued on arrival, cannot be extended.

DOCUMENTS REQUIRED:

1. Clear legible **COLOR** copy of the First (Data) Page of Passport in actual size (professional copy only!) Please make sure that the passport is signed!
2. Professional **current** passport photograph meeting the following requirements:
 - a. Photo should present full face, front view, eyes open and without glasses.
 - b. The height and width of the Photo must be equal.
 - c. Background should be plain light colored or white.
 - d. No shadows on the face or on the background, no borders.

Please answer **legibly** and completely ALL the questions below in block letters and return to GenVisa with the rest of the required information listed on the Tourist Visa Requirements form.

Please Note: The online visa application form is an Indian government run website; therefore GenVisa is unable to offer technical support to applicants completing their own applications. Applicants, who chose to complete online application themselves, should take great care to fill in the information correctly. Any mistakes will delay processing and/or require the process to be repeated.
