- ___ Prepaid self-addressed first-class **mail envelope** if you wish to receive physical copies of your receipts.
- ___ **Payment:** a check or money order payable to **GenVisa** in US Dollars and drawn on a US bank.

Important: Do not send your passport/materials more than 6 months prior to your trip date. An ETA is an official authorization for a short visit to Turkey for tourism or business purposes, visa is valid for six months from the date of entry into Turkey for multiple entries of up to 90 days per visit. The ETA is submitted online with the ETA approval communicated via email. **You MUST always carry the ETA approval with you.**

If you need your ETA within 5 days: add \$35 per person for expedited service. These requirements are for nationals of United States and Canada only. The ETA is submitted online with the ETA approval communicated via email. You **MUST** always carry the ETA approval with you. Confirmed onward or return airline ticket must be shown at the point of entry in Turkey.
