- **High Resolution color copy of the data page of your passport**, with at least **six months of remaining** validity beyond the travel date. The passport should have at least two blank pages for stamping by the Immigration Officer. If you need help securing, renewing, or updating your passport, please contact GenVisa at (800) 845-8968 for requirements and fees.
- **One (1) recent high-resolution professional photo** per person (approx. 2" x 2"). **Photos must be on the white background!** Please do not wear glasses! **Please do not staple!**
- India application will be submitted on your behalf by GenVisa staff on line, using the information provided on **India E-Visa Request form** enclosed in the visa kit.
- Prepaid self-addressed first-class mail envelope if you wish to receive a physical copy of your E-Visa.
- **Payment:** a check or money order payable to GenVisa in US Dollars, drawn on a US bank.
Complete and *return this entire form* with the requested materials – use a traceable form of mail.
Important: Do not send your request/materials more than 4 months prior to your tour departure date.

Processing generally takes up to 3 weeks. If you need your E-Visa **within 14 days: add \$45 per person for expedited service.** For processing **within 7 business days: add \$75 per person.** If you are a non-US citizen, call for entry requirements.
