An ETA is an official authorization for a short visit to Turkey for tourism or business purposes, visa is valid for six months from the date of entry into Turkey for multiple entries of up to 90 days per visit. The ETA is submitted online with the ETA approval communicated via email. You MUST carry the ETA approval with you at all times.

If you need your ETA within 5 days: add \$25 per person for expedited service. These requirements are for nationals of United States and Canada only. For all other nationalities call GenVisa for entry requirements. ***Government fees are subject to change without notice.**

Amendment and Endorsement pages in the back of the passport are not suitable for visa placement. The Turkey (ETA) is electronic and will not be stamped inside the passport. The ETA is submitted online with the ETA approval communicated via email. You **MUST** carry the ETA approval with you at all times. Confirmed onward or return airline ticket must be shown at the point of entry in Turkey.
